A. Privacy Policy for EU/EEA

1. Collection of data

We collect and process the following categories of personal data as part of the application process:

- Personal master data and contact details in your candidate profile (e.g., first and last name, country, email address, phone number).
- Information provided by you as part of the application form (e.g., information on salary expectations, your motivation, work permit for the respective country, as well as disability information if applicable (if relevant for the advertised position)).
- Application documents (including, for example, resume, cover letter, professional development data, qualifications or language skills).
- Results of online procedures (e.g., performance tests) and video interviews, if applicable.
- Results of medical fitness examination (e.g. statement on suitability, necessity of a hearing or visual aid), if required by law.
- Document submission of ID or Visa Documents to verify the legal Eligibility to enter into an employment contract in the intended country of engagement (if necessary).
- Additional information and documents (such as references) if and to the extent that you provide them to us.

If and to the extent that performance tests are given, we evaluate the results using relevant reference groups, taking into account your profession and your level of experience.

We may also obtain the personal data about you listed above from other sources or from external business partners, such as HR service providers. This data may also originate, for example, from professional social networks where you have published it, e.g., LinkedIn. This may also involve data that you have provided us via third-party websites, e.g., job portals, or data that you have published in other publicly accessible sources. This data is limited to data that is relevant to your professional career and solely for the purpose of communicating job offers from our group of undertakings or aligning the accuracy of your information in the application documents.

2. Purposes of processing

We collect and process your personal data to be able to offer advertised positions and carry out the selection process. In this case, we process your personal data exclusively for the following purposes:

- To be able to identify you as an applicant.

- To take notes and make assessments to decide on suitability for the job.
- To initiate and establish an employment relationship.
- To contact you if you should be considered for an alternative position (depending on whether you give us your consent to do so).
- To ask you about your satisfaction with the application process, provided you have given us your consent for this.
- To contact you about your speculative application.
- To send you personalized information about open positions at Flix companies based on your consent.
- To save you in our talent pool for any other suitable job offers based on your previously granted consent.

If your application is successful, the application data transmitted by you to Flix will also be processed to complete the recruitment process, particularly to conclude an employment contract with you, as well as in connection with administrative matters related to your employment.

3. Legal bases

We process your personal data within the scope of the application process only to the extent permitted by an applicable legal provision, i.e. based on the provisions of the GDPR. In doing so, we will base the processing of your personal data on the following legal bases, among others:

- **For the decision on establishing the employment relationship:** Your personal data will be collected and processed in order to fill advertised positions and to carry out the selection process. We process your data primarily to establish the employment relationship on the basis of Art. 6 para. 1(b) GDPR. In addition, we take notes on the content of the interview using an application based on artificial intelligence, the legal basis is Art. 6 para. 1 (f) GDPR. Our legitimate interest is to fully focus on the interview with you and make well-informed hiring decisions. If you prefer that the notes be taken manually rather than by AI, you can object to the use of the AI Notetaker in the related email.
- **To fulfill legal obligations:** We process your data to fulfill legal obligations, e.g. in case the law requires the performance of medical fitness examination (on the basis of § 47 EOB, Triebfahrzeugführerschein-Verordnung (TfV) or Schrift 714 „Leitlinien für die Beurteilung der Betriebsdiensttauglichkeit in Verkehrsunternehmen“). This data processing is carried out on the basis of Art. 6 para. 1(c) GDPR.
- **Based on your consent:** If you voluntarily provide us with special categories of personal data, we will only process them on the basis of your consent. The legal basis for this is Art. 6 para. 1(a) GDPR.

If we have invited you to participate in a survey about your satisfaction with the application process at Flix, the relevant legal basis is your consent pursuant to Art. 6 para. 1 (a) GDPR. Your registration for the “Career Portal”, where you receive personalized information about current job postings at Flix, is also based on this legal basis.

If a performance test is planned for the respective position, participation in these tests is voluntary and requires your consent. You can decline to participate in such a test. The legal basis for this is Art. 6 para. 1(a) GDPR.

As part of the application process, we offer suitable applicants the option of being stored in our talent pool for a period of one year based on consent within the meaning of Art. 6 para. 1(a). This consent is voluntary and can be revoked at any time for the future.

- **To safeguard legitimate interests:** In individual cases, we process your data in order to protect legitimate interests of Flix or third parties. A legitimate interest exists, for example, if your data is required to assert, exercise or defend legal claims within the scope of the application process (e.g., claims under the General Equal Treatment Act). In these cases, the data processing takes place on the basis of Art. 6 para. 1 (f) GDPR. A legitimate interest is, for example, the need to provide evidence in proceedings.

If we use information from public profiles on professional social networks, the legal basis for the processing - creating a basis for the decision on establishing an employment relationship with you - shall be considered in our legitimate interests. The legal basis is Art. 6 para. 1(f) GDPR in conjunction with Art. 9 para. 2(e) GDPR.

Personal data that you provide during the application process is generally voluntary. However, it is necessary to provide this personal data for the processing of your application or the conclusion of an employment contract.

4. Data recipients

Your personal data may be transmitted by us to affiliated companies, provided this is permitted within the framework of the purposes and legal bases set out above. After your application has been received, your applicant data will only be submitted to those offices that require them to carry out the application process. In addition to the company posting the job and the employees of the department that is hiring, these are generally also the responsible employees of the Human Resources Department of Flix SE.

Your personal data may also be processed on our behalf based on contracts pursuant to Art. 28 GDPR, in particular by system providers as part of applicant management or the completion of the application process. Personal data will not be transferred to third parties if there is no reference to applicant management and the applicant selection processes or outside of the purposes described in the “Purposes of processing” section.

Our Career Portal is technically implemented via the service provider Greenhouse Software, Inc., 110 Fifth Avenue, 3d Fl., New York, NY 10011 USA (hereinafter also referred to as “Greenhouse”). Greenhouse processes your data on our behalf as a processor. Your personal data will be transmitted to Greenhouse for the purposes of this processing. These transfers can therefore be transfers of personal data to recipients outside the European Union or the European Economic Area. We have concluded standard contractual clauses with these external service providers if they are not based in countries with adequacy decisions in accordance with Art. 45 GDPR. In the case of a legal obligation, we reserve the right to disclose information about you if we are required to disclose it to lawfully acting authorities or law enforcement bodies; the legal basis is Art. 6 para. 1(c) GDPR.

5. Your rights

You may assert your rights as a data subject regarding your personal data at any time, in particular by contacting us using the contact details provided in Clause 1. According to the GDPR, you have the rights listed below:

Right to information

You can request information in accordance with Art. 15 GDPR about your personal data processed by us. In your request for information, you should clarify your concern to make it easier for us to compile the necessary data. Upon request, we will provide you with a copy of the data that are the subject matter of the processing. Please note that your right to information may be limited under certain circumstances in accordance with statutory provisions.

Right to rectification

If the information relating to you is not (any longer) correct, you may request a correction in accordance with Art. 16 GDPR. If your data is incomplete, you may request completion.

Right to erasure

You may request the erasure of your personal data in accordance with the provisions of Art. 17 GDPR. Your right to erasure depends, among other things, on whether the data relating to you are still required by us to perform our statutory duties.

Right to restriction of processing

In accordance with the provisions of Art. 18 GDPR, you have the right to demand a restriction of the processing of the data relating to you.

Right to data portability

In accordance with the provisions of Art. 20 GDPR, you have the right to receive the data that you have provided to us in a structured, commonly used and machine-readable format, or to request the transmission to another controller.

Right to object

In accordance with Art. 21 para. 1 GDPR, you have the right to object to the processing of your data at any time for reasons relating to your particular situation. You can object to receiving advertising at any time with effect for the future, in accordance with Art. 21 para. 2 GDPR (objection to advertising in the case of direct marketing).

Right to appeal

If you are of the opinion that we have not complied with the provisions of data protection regulations when processing your data, you can complain to a data protection supervisory authority about the processing of your personal data.

Right to withdraw consent

You can withdraw your consent to the processing of your data at any time with future effect.

6. Storage/retention periods

We store your personal data for a period of 6 months after sending the rejection for the respective position. This storage period is particularly necessary for cases in which we must fulfill obligations to provide evidence in proceedings under the General Equal Treatment Act (AGG) in Germany (or similar laws in other jurisdictions) or defend ourselves against any claims asserted.

If you have given your consent, we will store your data for this period in case there is another job posting you are a suitable candidate for.

If you have consented to be included in our talent pool as part of the application process, your application documents will be processed in the talent pool solely within the framework of future job postings that could be suitable for you and will be destroyed after a period of one year at the latest.

In the event that your application is successful, we will store your personal data for the entire duration of your employment relationship in accordance with the Privacy Policy for Employees, which we will send you upon acceptance of employment.

7. Special provisions for applications as bus driver

If you apply to become a bus driver via our platform, the following specific rules apply in addition to the general principles above:

- Flix SE is responsible for an internal security check and forwarding your data to the respective Buspartner.
- The respective Buspartner is responsible for the subsequent application process.

B. Privacy Policy for UK

Applicable law

The processing of your personal data in connection with your application is governed by the UK General Data Protection Regulation ("**UK GDPR**") and the Data Protection Act 2018 as amended by the Data (Use and Access) Act 2025. References to "GDPR" in the EU/EEA section above should be read as references to the UK GDPR where this section applies.

1. Collection of data

The categories of personal data collected are the same as described in the EU/EEA section above.

2. Purposes and legal bases

We process your personal data for the same purposes as described in the EU/EEA section above. The legal bases are the equivalent provisions under UK GDPR Art. 6 and, where applicable, Art. 9.

3. Data recipients and third country transfers

Your personal data may be shared with affiliated companies and processors as described in the EU/EEA section above. Where data is transferred to a third country (a country outside the United Kingdom), we ensure adequate protection is in place through UK adequacy regulations, UK International Data Transfer Agreements (IDTAs), the UK Addendum to EU Standard Contractual Clauses, or other appropriate safeguards recognised under UK GDPR.

4. Your rights

You have the same rights as described in the EU/EEA section above, under the equivalent provisions of UK GDPR (Arts. 15–21 UK GDPR).

We will acknowledge receipt within 30 days and inform you of the outcome.

5. Storage/retention periods

Retention periods are the same as described in the EU/EEA section above, subject to applicable UK statutory obligations in place of the German law references in that section.

Flix North America Inc. Job Applicant Privacy Notice ("Job Applicant Notice")

This Job Applicant Notice describes how Flix North America Inc. ("**Company**," "**we**," "**us**," or "**our**") processes personal information ("**PI**") of our job applicants in the human resources ("**HR**") context.

For California job applicants, this Job Applicant Notice is designed to meet obligations under the California Consumer Privacy Act, as amended by the California Privacy Rights Act (together, the "**CCPA**"). In the event of a conflict between any other Company policy, statement, or notice and this Job Applicant Notice, this Job Applicant Notice will prevail as to our California job applicants, unless stated otherwise. Capitalized terms used but not defined in this Job Applicant Notice shall have the meanings given to them under the CCPA.

Section 1 of this Job Applicant Notice provides notice of our data practices, including our collection, use, retention, and disclosure of our job applicant PI. Section 2 of this Job Applicant Notice provide information regarding rights our California job applicants have under the CCPA and how you may exercise them.

Non-Applicability: This Job Applicant Notice does not apply to our consumer facing website(s), which are addressed in our general privacy notice available [here](#). Our other personnel, such as current and former employees and independent contractors, can learn about our data practices as relates to them by contacting data.protection@flix.com and can exercise their rights as set forth in section 2 of this Job Applicant Notice.

1. NOTICE OF DATA PRACTICES

The description of our data practices in this Job Applicant Notice covers the twelve (12) months prior to the Effective Date and will be updated at least annually. Our data practices may differ between updates, however, if materially different from this Job Applicant Notice, we will provide supplemental pre-collection notice of the current practices, which may include references to other privacy policies, notices, or statements. Otherwise, this Job Applicant Notice serves as our notice at collection.

(a) PI Sources and Use

We may collect your PI directly from you when you apply for a position with us (e.g., contact details, educational and employment data), your devices; our affiliates; our service providers; public sources of data; professional social networks (e.g., LinkedIn), or third parties (e.g., references).

Generally, we use job applicant PI for HR Business Purposes and as otherwise related to the operation of our business, including for: Performing Services; Managing Interactions and Transactions; Security; Debugging; Quality Assurance; Processing Interactions and Transactions; and Research and Development. For example, we use job applicant PI for the following purposes:

- Recruitment (e.g., to include you in our talent pool for future job postings you could be suitable for);
- Running background checks;
- Maintaining personnel records;
- Sending personalized information about open positions;
- HR IT systems and security;
- Health & safety/occupational health; and
- Security (including electronic and of premises)

We may also use PI for “**Additional Business Purposes**” in a context that is not a Sale or Share under the CCPA, such as:

- Disclosing it to our Service Providers, Contractors, or Processors that perform services for us (“**Vendors**”);
- Disclosing it to you or to other parties at your direction or through your action (e.g., some software platform operators.);

- To assignees as part of an acquisition, merger, asset sale, or other transaction where another party assumes control over all or part of our business (“**Corporate Transaction**”).

Subject to restrictions and obligations under the CCPA, our Vendors may also use your PI for Business Purposes and Additional Business Purposes, and may engage their own vendors to enable them to perform services for us.

There may be additional information we collect that meets the definition of PI under the CCPA but is not reflected by a category above, in which case we will treat it as PI as required but will not include it when we describe our practices by PI category.

Please note that we use an AI-supported application to take notes during candidate interviews. The AI, however, does not make automatic employment or hiring decisions. If you prefer that the notes be taken manually rather than by AI, you can object to the use of the AI Notetaker in the related email.

As permitted by applicable law, we do not treat deidentified data or aggregate consumer information as PI and we reserve the right to convert, or permit others to convert, your PI into deidentified data or aggregate consumer information, and may elect not to treat publicly available information as PI. We will not attempt to reidentify data that we maintain as deidentified.

Because there are numerous types of PI in each category of PI, and various uses for each PI type, our retention periods vary for each of the categories of PI described above. The length of time for which we retain each category of PI depends on the purposes for our collection and use and requirements pursuant to applicable laws. For example, where we send a rejection for a position, we may retain your PI for up to seven (7) years after sending the rejection to (a) comply with legal requirements or (b) subject to your right to make a deletion request, in connection with the reopening of the position you applied for or other positions you may be a suitable candidate for. The criteria used to determine the retention period of PI includes the nature and sensitivity of the PI, the potential risk of harm from unauthorized use or disclosure of the PI, as well as applicable laws (such as applicable statutes of limitation).

2. California Job Applicants Only

(a) Your Rights and How to Exercise Them

Right to Limit Use and Disclosure of Sensitive PI

Notwithstanding anything to the contrary, we may collect, use and disclose your PI as required or permitted by applicable law and this may override your rights under the CCPA. In addition, we are not required to honor your requests to the extent that doing so would infringe upon our or another person's or party's rights or conflict with applicable law.

This may include migrating your information to other platforms owned by us. We may disclose any information in response to a legal request such as a subpoena, court order, or government demand, to investigate or report illegal activity, or to enforce our rights or defend claims. We may also transfer your information to another company in connection with a partnership or a corporate restructuring, such as a sale or merger.

Please be aware that this Privacy Policy, and any other policies in place, in addition to any amendments, do not create rights enforceable by third parties.

8. Law Enforcement

You understand that we may disclose your information to authorities if compelled to by a court order or by an investigating agency/regulatory body in the lawful exercise of the powers conferred on such investigating agency/regulatory body. Additionally, you understand that we may disclose your information if we reasonably believe that you have breached laws of India, or international laws or the agreements/terms of service that govern the provision of our services to you or this Privacy Policy. We are under no obligation to inform you of any disclosures or potential disclosures of your information as mentioned in this paragraph. You release us from any claims for damages that may arise from or relate to the release of your information in compliance with a court order or a request made by an investigating agency/regulatory body. We may release your information under the conditions listed in this paragraph whether it is to individuals or entities and to any state or national authorities, as required.

9. Commercial and Non-Commercial Communications

5. Your rights

- If your application is successful, the application data transmitted by you to Flix will also be processed to complete the application process, particularly to conclude an employment contract with you, as well as in connection with administrative matters related to your employment.

The legal basis for this processing is regulated under the provisions established in Law No. 29733, Personal Data Protection Law and its Regulations – Supreme Decree No. 016-2024-JUS.

Also, we take notes on the content of the interview using an application based on artificial intelligence. Our legitimate interest is to fully focus on the interview with you and make well-informed hiring decisions.

In addition, if you have given your free, prior, and informed consent, we may also use your personal data:

- To contact you if you should be considered for an alternative or different position
- To send you personalized information about open positions at Flix
- To save you in our talent pool for any other suitable job offers

Personal data that you provide during the application process is generally voluntary.

However, it is necessary to provide this personal data for the processing of your application or the conclusion of an employment contract.

3. Personal Data Controller and contact details

The Flix company named in the job posting you have applied to (hereinafter: Flix) is responsible for processing your personal data within the framework of your application. You can contact this company using the details provided in the job posting.

4. Data recipients

Flix may transfer your personal data to service providers and group companies that support the recruitment process, such as applicant tracking platforms, assessment service providers, and HR software vendors. 2. **Right to Rectification, Updating, and Inclusion:** Applicants have the right to update, include, and rectify their personal data when it is partially or totally inaccurate, incomplete, or when an omission, error, or falsehood has been identified.
3. **Right to Cancellation or Deletion:** Applicants may request the cancellation or deletion of their personal data when it is no longer necessary or relevant for the purpose for which it was collected.

4. **Right to Object:** Applicants may object to the processing of their personal data at any time. The objection will be valid as long as the processing does not have legitimate or legal grounds.
5. **Right to Data Portability:** Applicants may request their personal data, which they have provided to Flix or a data processor, in a structured, commonly used, and machine-readable format. They may also request the transfer of their data to another data controller when processing is based on consent or a contractual relationship, or when processing is carried out through automated means.

I. Privacy Policy for Australia

FlixBus Australia Pty Ltd (**Flix Australia**) understands the importance of protecting the privacy of an individual's personal information.

This policy sets out how Flix Australia aims to protect the privacy of your personal information which it collects in connection with your application for employment with Flix Australia, your rights in relation to your personal information managed by Flix Australia and the way Flix Australia collects, holds, uses and discloses your personal information.

In handling your personal information, Flix Australia complies with the *Privacy Act 1988* (Cth) (**Privacy Act**), the Australian Privacy Principles (**APPs**) in the Privacy Act, and applicable health records legislation.

1. What kinds of personal information does Flix Australia collect from Applicants?

Personal information is information or an opinion about an identified, or reasonably identifiable, individual.

During the recruitment process, Flix Australia will collect your personal information when you register your interest in a role(s) and when you provide personal information in connection with your application, and will hold, use and disclose your personal information for the purposes of assessing your suitability for employment.

Generally, the kinds of personal information that Flix Australia will collect about you in connection with your application for employment include:

- (a) contact and identification information such as your name, residential address, telephone number, email address, date of birth, and identity verification information (where applicable);
- (b) information about your education and work history, experience, qualifications and skills, and the opinions of others about your work performance;
- (c) information and results from interviews and psychometric or competency assessments;
- (d) health information which will only be collected where it is relevant to Flix Australia's assessment of whether you are able to perform the inherent requirements of a particular position and with your consent;
- (e) criminal record information, which will only be collected where relevant to the recruitment process and with your consent;
- (f) other personal information obtained during the application process from documentation you submit to us, for example from your resume and cover letter; and

- (g) other information required for our recruitment functions, including where required by law.

In some circumstances, Flix Australia may also hold other personal information provided by you or obtained from third parties about you with your consent.

2. How does Flix Australia collect personal information?

Generally, Flix Australia collects your personal information directly from you. For example, Flix Australia may collect your personal information through:

- (a) your completion of a manual or online job application form and provision of documentation in connection with your application;
- (b) an interaction or exchange with you, whether in person or by way of telephone, video conference, email, or other electronic communication or post; and/or
- (c) your use or access of Flix Australia's website.

There may be occasions when Flix Australia collects your personal information from other sources, including: [

- (a) a third party website, when you register your interest in one of our advertised roles via such website;
- (b) background screening service providers;
- (c) referees or third parties with whom you have previously worked;
- (d) educational institutions with whom you have completed a qualification;
- (e) psychometric or competency assessment providers with whom you undertake pre employment psychometric testing or competency assessments; and/or
- (f) a publicly maintained record or other publicly available source of information including social media, such as LinkedIn.

Generally, Flix Australia will only collect your personal information from sources other than you if it is unreasonable or impracticable to collect your personal information from you or with your consent.

3. Why does Flix Australia need your personal information?

Flix Australia collects, holds, uses and discloses your personal information where it is reasonably necessary for the purposes of assessing your suitability for employment.

Flix Australia may also use or disclose your personal information for related purposes for which you would reasonably expect Flix Australia to use or disclose your personal

information, where you have consented to the use or disclosure, or where the use or disclosure is otherwise in accordance with law.

Where personal information is used or disclosed, Flix Australia takes steps reasonable in the circumstances to ensure it is relevant to the purpose for which it is used or disclosed.

You are under no obligation to provide your personal information to Flix Australia. However, without certain personal information from you, Flix Australia may not be able to assess your application for employment.

If Flix Australia receives personal information that it has not requested and determines that the personal information received is not reasonably necessary for the purposes of assessing your application for employment, Flix Australia will take all lawful and reasonable steps (if any) to de-identify or destroy that personal information.

4. To whom does Flix Australia disclose your personal information?

Flix Australia discloses your personal information for the purposes for which Flix Australia collects it. That is, generally, Flix Australia will only disclose your personal information for a purpose contemplated by section 3 above. This may include disclosing your personal information to:

- (a) third parties engaged by Flix Australia to perform business and administrative functions including but not limited to background screening, reference checking, and conducting psychometric testing or competency assessments;
- (b) with your consent, your current employer and/or any individuals who you nominate as referees to verify certain information;
- (c) other companies within Flix Australia's corporate group (who may be located overseas); and
- (d) regulatory bodies and agencies if and as necessary, including the Australian Taxation Office.

Flix Australia's disclosures of your personal information to the above third parties will be on a confidential basis or otherwise in accordance with the law. Flix Australia may also disclose your personal information with your consent or if disclosure is required or authorised by law.

5. Overseas disclosure

Flix Australia may disclose your personal information to overseas recipients in order to assess your application for employment. It is impracticable to list all countries in which recipients may be located but it is likely that such countries will include Germany, where Flix Australia's parent company is headquartered.

Overseas recipients may have different privacy and data protection standards. However, before disclosing any personal information to an overseas recipient, Flix Australia takes steps reasonable in the circumstances to ensure the overseas recipient complies with the APPs or is bound by a substantially similar privacy scheme unless you consent to the overseas disclosure or it is otherwise required or permitted by law. If you have any queries or objections to such overseas disclosure, please contact Flix Australia's Privacy Officer on the details set out in paragraph 9.

6. Security of your personal information

Flix Australia takes steps reasonable in the circumstances to ensure that the personal information it holds is protected from misuse, interference and loss and from unauthorised access, modification or disclosure.

Flix Australia holds personal information in both hard copy and electronic forms in secure servers or in storage located in secure environments. Flix Australia employees are required to maintain the confidentiality of any personal information held by Flix Australia.

Flix Australia will destroy or de-identify personal information in circumstances where it is no longer required, unless Flix Australia is otherwise required or authorised by law to retain the information.

7. Can you access and correct the personal information that Flix Australia holds about you?

Flix Australia takes steps reasonable in the circumstances to ensure personal information it holds is accurate, up-to-date, complete, relevant and not misleading.

Under the Privacy Act, you may seek access to and correction of your personal information that is collected and held by Flix Australia. If at any time you would like to access or correct the personal information that Flix Australia holds about you, or you would like more information on Flix Australia's approach to privacy, please contact Flix Australia's Privacy Officer on the details set out in paragraph 9 below.

Where Flix Australia outsources any functions relating to assessing your application for employment, any request for access to or correction of the personal information held by that service provider may need to be made to the relevant service provider.

Flix Australia will grant access to the extent required or authorised by the Privacy Act and take steps reasonable in the circumstances to correct personal information it holds about you where necessary and appropriate.

To obtain access to your personal information:

- (a) you will have to provide proof of your identity to enable Flix Australia to confirm that the personal information to which you seek access is about you, and to ensure that the privacy of others is protected;

- (b) Flix Australia requests that you be reasonably specific about the information you require; and
- (c) Flix Australia may charge you a reasonable administrative fee, which reflects the cost to Flix Australia, for providing access in accordance with your request.

Flix Australia will endeavor to respond to your request to access or correct your personal information within 30 days from receipt of your request.

8. Cookies

When accessing Flix Australia's website, or a related entity's website, Flix Australia uses 'cookies' to store a log file which is retained for technical and statistical purposes only.

Cookies are small pieces of information sent from the website and stored by your Internet browser on your computer's hard drive. You can disable cookies at any time. However, if a browser does not accept cookies or if you reject a cookie, some portions of Flix Australia's online services may not function properly.

To the extent any personal information is collected through Flix Australia's use of cookies, it is de-identified prior to being analysed for technical and statistical purposes.
